Omega Community Living is committed to achieving Net Zero emissions by 2040

Baseline Emissions Footprint Year: 2023-2024	
Additional Details relating to the Baseline Emissions Initiatives.	
Scope 1	We are committed to reducing our carbon footprint and have implemented several measures to achieve this. These include reducing our use of heating gas, choosing locally-produced and organic food, and cutting down on beef and dairy products. We are always looking for new ways to reduce our emissions, and we expect our carbon emissions to be around 1170 units by the end of 2024.
Scope 2	We take various steps to reduce our home's energy carbon footprint. These include cutting down on water usage by washing our cars less often and regularly checking for water leaks. We also insulate our house to prevent drafts, choose energy-efficient appliances, and opt for energy-saving air conditioning units, dishwashers, and refrigerators. Additionally, we turn off lights and computers when they're not in use and replace incandescent bulbs with compact fluorescent ones. We use a programmable model to turn off the heat and air conditioning when the office is empty to conserve energy. We expect to reduce our emissions by 1506 by 2024 through these measures.
Scope 3	We encourage our employees to consider walking or biking to work instead of driving in order to reduce carbon emissions. Additionally, we use traffic websites and apps to find alternative routes that bypass traffic jams. Our goal is to save fuel and minimize unnecessary CO2 emissions.

Scope 3	Our goal is to reduce emissions by 2023. To achieve this, we will be taking several steps such as reducing business travel by 100, minimising staff commuting by 500, minimising wastage by 1,100, and repurposing or recycling 1,500 office items that are no longer in use. These are the changes we plan to make internally to meet our emissions target.

<p>The organisation has implemented a local climate emergency action plan for Carbon Reduction, reporting Scope 1, Scope 2, and Scope 3 emissions. The management has approved the plan, aiming to decrease emissions by 2040 by offsetting unavoidable CO2 emissions. Implementations include virtual meetings using Microsoft Teams, LED lighting, energy reduction programs, and hybrid working models. Future measures include improving electricity consumption efficiencies, using GHG Protocol Standards for data reporting, reducing business travel emissions, promoting online meeting and collaboration tools, and using electric vehicles. By addressing local and global economic inequality and promoting cleaner energy sources, the organisation aims to reduce its carbon footprint and contribute to a more sustainable future.</p>
